### **Report of the Committee of Management for the year to 30 September 2014**

The Report is as printed on pages 6, 7 and 8 of the LUCS News. There have been a number of highlights in the last year. We were runners-up recently in the Tourism Award for Visit West Lothian. We now have people coming to us asking to be included in our tourism adverts. Two television companies have been here this year. Michael Portillo with his programme Great Railway Journeys and Timothy West and Prunella Scales with their Great Canals series. Both should be aired in the new year and members will be notified in advance of these. Victoria was used to carry the Commonwealth Games Baton as part of the Linlithgow section which was also televised. Our association with other societies on the canal are getting closer, namely the 1940 group who have brought their boat Bluebell to the basin to cover our aqueduct trips when St Magdalene is on Falkirk Wheel trips. They have thoroughly enjoyed being involved. ReUnion now have a day hire boat which has prompted us to do a refurbishment of Leamington. This is now ongoing. Mike Vickers is still helping us out with Leader grants. Chris Matheson-Deare has now relinquished drivers' rotas. A vote of thanks was called for. We are also reviewing our website to cope with electronic devices as this seems to be one of the most popular ways to access us.

### **Proposals for the season 2015**

Next year is the Society's 40<sup>th</sup> birthday. It is intended to hold an event in April hopefully with a lunch for members (especially founder members), flotillas, etc. It is proposed to refurbish and upgrade St Magalene. Leamington refurbishment is now under way. Funding for the completion of the driveway has been granted and work should start on this in January.

### **Any other business**

Norman Foulner voiced his concerns about the viability of the canal as he feels there are fewer boats using it. Scottish Canals have promoted the idea of Living on Water and there are pontoons in Linlithgow. He asked if the committee would look into the possibility of the society purchasing one of these boats and renting it out on a short or long term basis. It was agreed that the committee would consider looking into this.

Danny Callaghan mentioned the new boat fund and it was explained that as a new boat would cost in the region of £100,000 a complete upgrade and alteration of St Magdalene would be the way forward bringing her out of the water in September 2015 and commencing work then.

Richard Toleman gave an update on the canal towpath upgrade. This seems to be moving along well.

Following the closure of the meeting, David Shirres showed the highlights of the year including a trip to the Kelpies and Fun Day, etc., - it was well-received.
